The Chicago/Turabian style of citing sources is generally used when citing sources for humanities papers, and is best known for its requirement that writers place bibliographic citations at the bottom of a page or at the end of a paper.

Identifying Sources in
the Body of Your Paper

The first time you cite a source, it is almost always a good idea to mention its author (s), title, and genre (book, article, or web page, etc.). If the source is central to your work, you may want to introduce it in a separate sentence or two,

To cite paraphrased material in the text of your paper, put the author's last name in parentheses at the end of the sentence where the paraphrase appears.

Place a comma after the author's name, then type the year the source was published. Place the period ending the sentence after the closing parentheses mark.

In-text citations: Author-page style MLA format follows the author-page method of in-text citation. This means that the author's last name and the page number (s) from which the quotation or paraphrase is taken must appear in the text, and a complete reference should appear on your Works Cited page.
