Written Resolutions. A resolution in writing signed by at least two Directors nominated by Party A and at least two Directors nominated by Party B or by signed facsimile of their signatures shall be valid and effective for all purposes as if passed at a duly convened meeting of the Board. Any such resolution may consist of one or several documents in like form, each signed or authenticated by one or more of the Directors.

Resolutions are a formal way of stating intended action by a group of people. A resolution is an original motion, which because of its importance, length, or complexity is submitted in writing. It is then brought forward on the floor of a local unit general membership meeting, state convention, or national convention for wider adoption.

Resolutions / How To Write A Resolution

Shareholder written resolutions. For a written (whether ordinary or special) shareholders' resolution to be passed, the requirements are the same as those at a general meeting: Ordinary resolution – more than 50% (a 'simple majority') Special resolution – 75% or more; These are the same percentage requirements that would be required in a meeting.

Because of the form — beginning with the word Resolved and following with either a statement of opinion or a statement authorizing or directing some action — such a motion is called a resolution. Here's an example of a common resolution: " Resolved, That it is the sense of this assembly that the organization commend our city council for repairing our streets without raising our taxes."
